- Loan policy of the Ina family, magistrate in the shogunate and the disturbance among its retainers. The article delves into the financial policy carried out by the Ina family from the beginning of the 18th century to its end. Furthermore, it enquires into the link between the above policy and the rivalry among its retainers which resulted in the downfall of Mr. Ina.

- An introduction to the history of forestry in modern Japan. Part X11*Hiroshi Hōjō* (29)
- Concerns of gentleman farmers in mountainous villages and their intelligence activities. —focused on '*Kokon marenaru nendaiki*' (the Chronicle unequaled in history) of the Hiranuma family, Kami Naguri-mura (village), Chichibu-gun (county), Musashi-no-kuni—The three successive heads of the Hiranuma family have continued keeping a record from 1846 until 1919. Scrutiny and the analytical study of the chronicle show detailed accounts of their concerns and information about internal policy, foreign policy, regional regulation, social event, occupation, life, calamity and so forth.*Morihiro Katō* (41)
- Development of lumber production in the Yoshino region in Edo Japan. The Hayashi family, Yoshino-machi (town), a heavily forested region in Nara Prefecture, has an inheritance of '*kuchiyaku mokuroku*' (account books of 1667, 1735 and 1768 in which '*kuchiyaku gin*', the unique local distribution tax at the time has been recorded.). Through a basic analytical approach to the above documents, the writer argues on the development of lumber production from the latter half of the 17th century to the middle of the 19th century.*Yahei Tani* (61)
- Osaka-bound lumber shipments from Owari and Atsuta-based shipping agents in the *Genroku* —*Kyōho* periods. A survey of the movements of the merchants dealing with lumber shipments from Owari to Osaka in the *Genroku*, *Hōei*, *Shōtoku*, *Kyōho* (1688–1735) periods—the periods in which strife between the shipping agents in Atsuta versus those in the neigh boring Nagoya to protect their own rights and interests does not occur as yet.
.....*Hirokazu Magarida* (79)
- The control of the basin of the River Kiso by the modern Owari clan with the focus on the control of driftwood. Analysis of *kawaho* (rules related to the fluvial control) initiated by the Owari clan for the control of driftwood on the Kiso River and the administrative system for its implementation. With the years from 1615 through 1867 being divided into the five periods, the writer argues on changes and characteristics of each period.*Yoriko Hayashi* (93)
- A basic study of the o-ishi (physicians) serving the Owari Tokugawas (Part 3) *Kinsoh o-ishi* (physicians whose speciality is an injury done by an arm) and *Fuchinin ishi* (physicians receiving rice as salary) from *Keian* period (1648–51) to *Tenpō* period (1830–43).
.....*Tetsunori Iwashita* (115)
- The succession and transfer of the books once owned by the Owari clan—The normal school's property to private ownership. The beginning of the Meiji era has marked the emergence of schools at various places throughout the present Aichi Prefecture. The origin of these schools can be traced back to the old *Hanko* or feudal clan's school. While explaining the process of formation of the normal school, the treatise argues on the transfer of the books once owned by the Owari clan made from the normal school to civilians in 1878.*Hajime Suda* (125)
- Okakura Tenshin's comments on the Japanese culture. The technique of counterpoint employed in his 'the Book of Tea'. A treatise on the Japanese civilization and *Sado* (tea ceremony) culture as viewed from the standpoint of 'Teaism' in the "Book of Tea".
